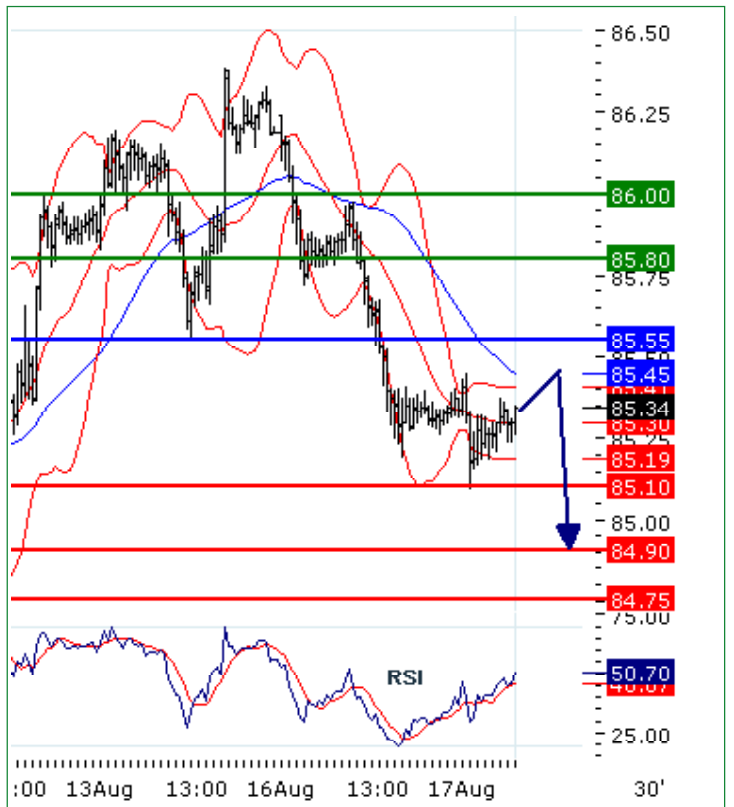
Alternative scenario: The upside penetration of 85.55 will call for 85.8 & 86.
